REQUIREMENTS FOR MEMBERSHIP:

1. Complete signed Membership Application and Waiver. Primary and Secondary Sponsors must be from different households (i.e. – not husband and wife from the same household). Submit to SSBC Membership

2. Membership must be approved by a simple majority of the Board of Directors.

3. Payment of \$140.00 (\$170 annual membership and \$30 for SSBC burgee) with application or within two (2) weeks after notification letter.

4. Attend an SSBC sponsored event prior to membership application.

5. Volunteer, or allow to be selected to an SSBC event committee, for participation in an event.

6. If any of the above requirements are not fulfilled in a timely fashion, your application may be changed from being

7. All members are required to attend a minimum of 2 events each calendar year. an approved member to being placed on the waiting list for membership.

WAITING LIST REQUIREMENTS:

SSBC's By-Laws require a maximum of 120 paid members at any time. When the total membership of paid members reaches 120, we will begin a "Waiting List" for those wishing to become active members of SSBC. The rules for being on the Waiting List are as follows:

1. A potential member cannot be placed on to the Waiting List until their signed Membership Application and Waiver has been received by the Membership Director and is affirmatively voted on by the Board of Directors.

There are no exceptions to this rule.

2. No money is due from a Waiting List potential member. However, we encourage people on the Waiting List to attend up to a maximum of two (2) SSBC events prior to becoming a member in the Club. As a Waiting List potential member, you will be charged the "guest" fees for these events. Once you are notified of the change in status from being on the Waiting List to becoming an approved member of SSBC, you will have a maximum of two (2) weeks to submit the required membership monies as defined above.

3. For movement from the Waiting List to the Approved Member status, boat owners will take preference over those who do not own a boat.
